Dear Ms. Lavin,	

I refer to your request which you have made under the freedom of Information Act (FOI) 2014 for access to records held by this department, as follows:

- All data pertaining to the number of applications for passports received by the DFA and the number of applications successfully granted since January 2015, including the nature of passport application (citizens through, parents or descent for example) and the applicant's country of residence.
- All data pertaining to the number of applications for citizenship through naturalisation and the number of applications successfully granted since January 2015 including the applicant's country of origin.

I refer also to the acknowledgement of your request which was sent to you on 14 August, 2018.

As agreed during our telephone conversation of 15 August, for part 1 of your request, the passport service will endeavour to provide the information you seek but it is not possible to create a single report with the information broken down as requested. For part 2 of your request seeking information on the number of Irish citizens who have claimed Irish citizenship through naturalisation it was agreed that you will need to submit a request to the Department of Justice.

I am the deciding officer in the case. I wish to inform you that I have undertaken a search for records with regard to part 1 of your request. I have identified records that fall within the scope of your request and I have made a decision to grant these records as following:

Table 1 -The number of applications for passports received and the number issued since 1 January, 2015 to 31 July, 2018 by entitlement to citizenship.

All applications are subject to the terms of the Passports Act, 2008 ("the Act"), which provides a legal basis for the various policies and practices which are applied by the Passport Service in the issue of passports. Irish citizens are entitled to be issued with a passport, subject to the requirements of the Act. There is provision in the Act to refuse a person a passport. The most common grounds to refuse a person a passport would be in cases where:

- (a) The person's entitlement to Irish citizenship has not been demonstrated;
- (b) The person's identify has not been satisfactorily established;
- (c) The passport application is fraudulent or misleading;
- (d) In the case of children the consent for the issue of a passport by the legal guardians has not been provided.

The Act requires the Minister to write to the person, who is being refused a passport, and cite the reason(s) for passport refusal. The Minister is obliged to offer a period of time to the person to make any representations and/or provide additional information that may be relevant to the proposed course of action. These requirements are important as they protect the right of Irish citizens to obtain and hold a passport for travel, subject to the requirements of the Act.

We do not compile data on the number of passport applications that are rejected. In general the number of passport applications that do not result in a passport being issued is small.

In the case of the table above, the differences between the numbers of applications received and passports issued is accounted for by pending applications for which further information has been requested.

Applications are not generally measured by country of residence, however, it is possible to infer the country of residence by the channel of application for Ireland, Northern Ireland and Great Britain.

From 1 January 2015 to 31 July 2018, the Passport Service has received 2,019,376 applications from citizens resident in Ireland of which 1,980,233 were issued, 272,739 applications from citizens resident in Northern Ireland of which 256,631 were issued and 254,981 applications from citizens resident in Britain of which 232,343 were issued.

Tracking of passport applications is in general carried out against channel of application rather than by other metrics, including country of origin. Bearing this in mind, the following general breakdown of applications will give the available detail on the volume of applications received and issued since 1 January 2015 to 31 July, 2018 outside of Ireland, Northern Ireland and Britain.

Passport applications from persons outside the island of Ireland and Britain may be submitted either via the online passport renewal service at https://www.dfa.ie/passportonline or through the network of Irish Embassies and Consulates worldwide and a separate table is included below for the applications made through each of these channels.

Table 2: Overseas applications received and issued via the online system since the Online Passport Application service was launched in March 2017 to 1 July, 2018, a breakdown is included based on the applicant's postal address.
